Board Declares Special Cash Dividend of \$2.00 per share of Common Stock and Class A Common Stock and Regular Cash Dividend of \$0.50 per share of Common Stock and Class A Common Stock

Elgin, IL, July 11, 2017 — **John B. Sanfilippo & Son, Inc. (NASDAQ: JBSS)** (the “Company”) today announced that its Board of Directors (the “Board”) declared a special cash dividend (the “Special Dividend”) of \$2.00 per share on all issued and outstanding shares of Common Stock and Class A Common Stock of the Company. The Special Dividend will be in addition to a regular annual cash dividend of \$0.50 per share on all issued and outstanding shares of Common Stock and Class A Common Stock of the Company, which was also declared today (the “Annual Dividend”). The aggregate amount of the Special Dividend and the Annual Dividend will be approximately \$28.4 million.

The Special Dividend and the Annual Dividend will be paid on August 15, 2017 to stockholders of record as of the close of business on August 2, 2017.

“We are pleased to announce the \$2.00 per share Special Dividend and our first annual dividend of \$0.50 per share pursuant to our Dividend Policy,” stated Jeffrey T. Sanfilippo, Chairman and Chief Executive Officer. “Our financial performance in the first three quarters of fiscal 2017 has provided us the opportunity to return profits to our stockholders through these dividends. These dividends, like our previous dividends, further reinforces our goal of creating long-term stockholder value through the responsible use of cash. These dividends would not be possible without the hard work and dedication of all our employees,” Mr. Sanfilippo concluded.
